



Quorum Consulting Group Website Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.quorum401k.com and Quorum Consulting Group and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Quorum Consulting Group include www.quorum401k.com, Quorum and atu401k.com. The Quorum website is a Retirement Account access site. By using the Quorum website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with account services via our Site, Quorum may collect personally identifiable information, such as your:

- First and Last Name
- Social Security Number
- Mailing Address
- E-mail Address
- Phone Number
- Account Beneficiary Information

Quorum may also collect anonymous demographic information, which is not unique to you, such as your:

- Age

We do not collect any personal information about you unless you or your Plan Sponsor provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain services available on the Site. These may include: (a) enrolling in your retirement plan on our Site; (b) requesting any type of account liquidation on our site; (c) sending us an email message or (d) submitting retirement account transactional requests. To wit, we will use your information for, but not limited to, communicating with you in relation to the services you have requested from us. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

Quorum collects and uses your personal information to operate its website(s) and deliver the services you have requested.

Quorum may also use your personally identifiable information to provide you with retirement account information and services from Quorum, your Plan Sponsor and your Plan Sponsor's account custodian.

Sharing Information with Third Parties

Quorum does not sell, rent or lease its retirement plan or participant information to third parties.

Quorum may share data with your Plan Sponsor and/or your Plan Sponsor's account custodian to help perform account transactions, statistical analysis, send you email or postal mail or provide customer support. Your Plan Sponsor and your Plan Sponsor's custodian is prohibited from using your personal information except to provide these services to Quorum, and they are required to maintain the confidentiality of your information.

Quorum may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Quorum or the site; (b) protect and defend the rights or property of Quorum; and/or (c) act under exigent circumstances to protect the personal safety of users of Quorum, or the public.

Tracking User Behavior

Quorum may keep track of the websites and pages our users visit within Quorum, in order to determine what Quorum services are the most beneficial. This data is used to deliver customized content within Quorum to customers whose behavior indicates that they are interested in a particular subject area.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Quorum. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Quorum website.

Security of your Personal Information

Quorum secures your personal information from unauthorized access, use, or disclosure. Quorum uses the following methods for this purpose:

- SSL Protocol

When personal information (such as Social Security numbers) is transmitted to Quorum, it is protected through the use of encryption, such as the Secure Sockets Layer (SSL) protocol.

We strive to take appropriate security measures to protect against unauthorized access to or alteration of your personal information. Unfortunately, no data transmission over the Internet or any wireless network can be guaranteed to be 100% secure. As a result, while we strive to protect your personal information, you acknowledge that: (a) there are security and privacy limitations inherent to the Internet which are beyond our control; and (b) security, integrity, and

privacy of any and all information and data exchanged between you and us through this Site cannot be guaranteed.

Children Under Thirteen

Quorum does not knowingly collect personally identifiable information from children under the age of thirteen. You are providing parental consent for collection of identifiable information if you designate a beneficiary under the age of thirteen and disclose his or her information via the Quorum website. Quorum does not sell, rent or lease personally identifiable information from children under the age of thirteen.

E-mail Communications

From time to time, Quorum may contact you via email for the purpose of providing account information, providing account liquidation paperwork, plan notifications, confirmations and/or other general communication.

External Data Storage Sites

We may store your data on servers provided by third party hosting vendors with whom we have contracted.

Changes to this Statement

Quorum reserves the right to change this Privacy Policy from time to time. We will notify you about significant changes in the way we treat personal information by sending a notice to the primary email address specified in your account, by placing a prominent notice on our site, and/or by updating any privacy information on this page. Your continued use of the Site and/or Services available through this Site after such modifications will constitute your: (a) acknowledgment of the modified Privacy Policy; and (b) agreement to abide and be bound by that Policy.
